HOLDER ACCEPTS RISK OF INJURY AND CONSENTS TO USE OF HOLDER IN BROADCASTS. This ticket is a revocable license granted only to ticket holder (“Holder”) by the event organizers (“Management”). Management may revoke the license and eject or refuse entry to the Holder for violation of these terms, facility rules, protocols, guidelines, requirements, and/or policies, or any other reason as determined by Management without refund.
